(Compressor Station Site No. 7) Interim letter dated September 13, 1955, from the United States Department of the Interior, Bureau of Land Management, Cheyenne, Wyoming, affording permission to proceed with construction on the following described premises, to-wit:

A tract of land out of Sections 2 and 3, T. 21 N., R. 118 W., 6th Principal Meridian, Lincoln County, Wyoming, and further described as follows: BEGINNING at a stake set for the S.W. corner of said tract in the North Right of Way line of U.S. Highway No. 30-N, from which the common corner between Sections 2, 3, 10 and 11, T. 21 N., R. 118 W., 6th Principal Meridian, Lincoln Co., Wyoming, bears S. 69° 08' E., 851.08 feet; THENCE along the North Right of Way line of U. S. Highway No. 30-N, N. 83° 45' E., at 800.00 feet across the East line of Section 3 and the West line of Section 2, a total distance of 2,640.0 feet to a stake for corner; THENCE N. 06° 15' W., 1,320.0 feet to a stake for corner; THENCE S. 83° 45' W., at 1,695.43 feet cross the West line of Section 2 and the East line of Section 3, a total distance of 2,640.0 feet to a stake for corner; THENCE S. 06° 15' E., 1,320.0 feet to the point of beginning and containing 80.00 acres of land.
