Easement Deed

The United States of America, Department of the Interior, acting by and through the Bonneville Power Administrator, grantor, in consideration of the equitable settlement of the civil proceeding entitled "U.S.A. v. Tol, et al.," does hereby grant and convey unto L. L. Thomas and Hallie R. Thomas, husband and wife, grantees, their heirs and assigns, a perpetual easement over and upon the following described land, to-wit:

All that portion of the NEt of the NEt of Section 30,T. 2 N., R. 5 E., Wm M., Skamania County, Washington, which lies within a strip of land 300.0 feet in width of which 212.50 feet lie on the northerly side of and 87.50 feet lie on the southerly side of the Bonneville-Vancouver transmission line survey; said survey line being located as follows:

Beginning at a point which is the intersection of said survey line with the east line of the NEt of said Section 30, said point being 257.05 feet south of the section corner common to Sections 19, 20, 29 and 30, T. 2 N., R. 5 E., W. M.; thence S. 89° 39' 08" W., a distance of 1367.38 feet to a point on the west line of the NEt of the NEt of said Section 30, said point being 265.34 feet south and 1367.35 feet west of the section corner common to Sections 19, 20, 29 and 30, T. 2 N., R. 5 E., W. M.

The aforesaid easement is for ingress and egress over, across, and upon said parcel of land; for use thereof for customary agricultural purposes; for use of any well or natural springs or water courses thereon and the water therefrom; and for laying and maintaining water pipes under, upon, and across said parcel of land; all in such manner as in the opinion of the grantor will not interfere with the use and occupancy of said parcel of land by the grantor for the present or future construction, operation, and maintenance of an electric power transmission and distribution system thereon with wires and appurtenances convenient thereto.
