Johns and Ethella L. Johns, husband and wife, GRANTEES, the following described real estate, situate in the county of Skamania state of Washington:

Commencing at the southeast corner of Lot 6 Stevenson Park Addition according to the official plat thereof on file and of record in the office of the Auditor of Skamania County Washington, thence east 120 feet, thence south 100 feet to the Initial Point of description; thence from said initial point south to the center of Kanaka Creek, thence southerly along the center of Kanaka Creek to intersection of said center line with the south line of Lot 5 of said Stevenson Park Addition, thence continuing from said point of intersection in a southerly direction along the center of Kanaka Creek to intersection thereof with a line parallel to and 50 feet south of the north line of Lot 3 of said Stevenson Park Addition, thence west to the westerly line of said Lot 3, thence northerly along the westerly line of Lots 3, 4 and 5 to a point due west of the Initial Point, thence east to the Initial Point of description.
