WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Allen C. Park and Alice A. Park, his wife, in consideration of Twelve Hundred Fifty and 00/100 Dollars, to them paid by Theo. C. Moe and Tina Moe, husband and wife, do hereby grant, bargain, sell and convey unto said Theo. C. Moe and Tina Moe, their heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances situated in the County of Skamania, State of Washington, bounded and described as follows, to-wit:

A portion of Lots Three (3) and Four (4) of Section Twenty-Nine (29) Township Three (3) North, Range Eight (8) East of the Willamette Meridian, in said County of Skamania, State of Washington, described as follows:

Beginning at a point on the East line of said Lot 4 of said Section 29, One-Hundred (100) feet north of Engineer's Station 2051, plus 31.4, of the Survey of the Columbia Valley Railroad Co., and 702 feet South of the Northeast corner of said Lot 4, thence southwesterly, parallel to and 100 feet distant, northerly at right angles, from the line of said Survey, to the West line of Lot 3, thence South, on said line, to the Columbia River; thence easterly, along said bank of said River, to the East line of said Lot 4; thence North, along said East line, to point of beginning, containing 19.02 acres, more or less;

Together with a right to the waters of Carson Creek, sufficient to fill a three (3) inch pipe, to be taken at such point as will insure sufficient fall.

Said Water Right and premises being subject to the reservations and conditions mentioned in the Deed to Louis Gerlinger, dated May 2, 1906, and recorded at Page 595 of Book 1 of Deeds of said County, and the rights of the S. P. & S. Railway Company, as decreed by the Superior Court of the State of Washington for said County; and all other recorded reservations and easements pertaining thereto.

It is understood that grantors have made no representations as to the exact locations of the boundary lines of said land.
