GILE, Trustee, for and in consideration of Ten and no/loo (\$10.00) Dollars and other valuable considerations in hand paid, does hereby grant, bargain, sell and convey to JANE M. CAREY, a married woman, of Portland, Multnomah County, Oregon, the following described real property situated in the County of Skamania, State of Washington, to-wit:

The undivided 1/7 of the certain real property

which was heretofore acquired by Laura A. Moffett : by descent from Samuel M and Mary Jane Hamilton and also the undivided 1/7 of said real property which, in a like manner was acquired by Daisy B. Eastham, the whole thereof being described as follows: The Samuel and Mary Jane Hamilton D.L.C. designated as claim #40 being parts of Sections 19, 20, 29 and 30, and the Samuel M. Hamilton homestead, being Lots 1, 5, and 6 of Section 29 and Lots 5 and 6 of Section 30, all in Twp. 2 N., R. 7 E. of W.M., and containing altogether 784 acres more or less, and also all lands commonly designated Shoreland fronting and adjoining the premises above described.
