WARRANTY DEED

THE GRANTORS, ALLEN C. PARK and ALICE A. PARK, his wife, for and in consideration of Three Thousand and 00/100 DOLLARS in hand paid, convey and warrant to Raymond J. White the following described real estate situate in the County of Skamania, State of Washington, to-wit:

All of Lots One (1), Two (2), Three (3) and Four (4) of Section Thirty-one (31), Township Three (3) North, Range Eight (8), East of the Willamette Meridian; with the following exceptions, to-wit:

- (a) Except the right-of-way of the Spokane, Portland & Seattle Railway Company, as now located over and across said land lands; and also
- (b) Except the Right-of-way of Primary State Highway No. 8, as now located over and across said lands; said highway being otherwise known as the "Evergreen Highway"; and also
- (c) Except a strip of land lying between the northerly line of said Primary State Highway No. 8 and a line running parallel thereto, a distance of 275 feet, measured at right angles from the center line of said Highway, and extending from the west line of a certain tract of ground, to Engineering Survey Station 128/00 of said Highway, as surveyed over and across said Lots 2 and 3 of said Section 31, a distance of 200 feet, more or less.
