bridges and other necessary improvements, together with the right to make cuts and fills as the same may be required in connection with such construction and maintenance, having however, due regard for mining operations on the lands upon which such timber is situated

The grantors, their successors in interest and assigns, shall have the right to make reasonable use of any roads constructed by the grantee, at the grantor's own risk; the grantors to pay twenty-five cents (25¢) per net ton of their materials hauled over roads or bridges constructed by the grantee for the cost of maintenance of any such roads; and the grantor's use of said roads shall not interfere with the grantee's logging operations hereunder. The grantee shall not be required to maintain or construct roads not required for its logging operations.

Until such time as the timber hereby conveyed shall have been fully cut and removed, save with the written consent of the grantee first had and obtained, the grantors shall not give or grant to any other person, firm or corporation any right-of-way, easement or permit for the construction, use or improvement of roads over, along or across the real property hereinbefore described and referred to, nor shall any other roads be constructed thereon, save in connection with the use and development of the real property above described and the mining operations thereon and therein.

In the event the joinder of the grantor in applications for permits required under the laws of the State of Washington for cutting or removal of any of said timber is required, the grantors agree, on their own behalf and on behalf of their successors in interest and assigns, to join in any such applications.
