In consideration of the sum of \$25.00 to them paid by SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY, a corporation, hereinafter called the "Railway Company", the receipt of which is hereby acknowledged, the undersigned K. D. McNeel and Mary Lee Ann McNeel, husband and wife, hereby grant to the Railway Company the right, privilege and easement of maintaining open ditches upon two 15 foot strips of land adjacent to the southerly boundard line of the Railway Company's right of way near Home Valley, Washington, said strips of land being shown in red on a print marked Exhibit "A" attached hereto, and said two strips being more particularly described as follows:

(1) <u>Culvert # 61-66</u>

A strip of land 15 feet wide situated south of the southerly right of way line of Spokane, Portland and Seattle Railway Company in the south half of Section 36, Township 3 North, Range 8 East, Willamette Meridian, in the Jas. M. Findley D.L.C., Skamania County, Washington, and being 7.5 feet on each side of the following described center line:

Beginning at a point on said southerly railway right of way line that is south 4,621.04 feet, and east 3,454.96 feet from the northwest corner of said Section 36, thence S. 38° 04' W. 46.0 feet; thence S. 9° 51' E. 56.0 feet; thence S. 30° 51' E. 69.0 feet; thence S. 36° 09' W. 206 feet more or less to to the Columbia River and containing 0.130 acre more or less;

(2) <u>Culvert # 61-72</u>

A strip of land 15 feet wide situated south of the southerly right of way line of the Spokane, Portland and Seattle Railway Company in the south half of Section 36, Township 3 North, Range 8 East, Willamette Meridian, in the
