

Jas. M. Findley D.L.C., Skamania County, Washington, and being 7.5 feet on each side of the following described center line;

It is understood that the separate ditches from each of the culverts above mentioned will be extended to the Columbia River and that the Railway Company shall have free use and access of the above mentioned two strips of land for the construction and maintenance of said drainage ditches.
