

RIGHT-OF-WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that the undersigned a single person-husband and wife, for a good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby grant unto Public Utility District No. 1 of Skamania County, Washington, a municipal corporation of the State of Washington, and to its successors or assigns, the right to enter upon the lands of the undersigned, situated in the County of Skamania, State of Washington, and more particularly described as follows:

All of Lots 9, 10, 14 and 15 and the West $\frac{1}{2}$ of Lot 11, lying south of
Highway No. 8, (old location) being part of Seeley's Subdivision in
Section 19, Twp. 3N., Range 10, E. W. M.

the same being a tract of land approximately _____ acres in area, located 6 miles W from the Town of Underwood, and bound by land owned by Roy Anthon and Ross Sheppard and to place, construct, operate, repair, maintain, and replace thereon and in or upon all streets, roads or highways abutting said lands an electric transmission or distribution line or system, and 1 concrete reservoir, it being understood and agreed that said transmission and/or distribution line and reservoir shall be located approximately as the same is now surveyed and staked upon said ground, and to consist of approximately six pole locations and three anchor locations, and to cut and trim trees, brush and grasses to the extent necessary to keep them clear of said electric line or system and to cut down from time to time all dead, weak, leaning or dangerous trees or brush that are tall enough to strike the wires in fall.
