CERTIFICATE OF RIGHT OF WAY

THIS IS TO CERTIFY, that E. W. Picco engaged in the business of logging and lumbering
in the State of Washington, has complied with the provisions of the act of the Legislature
approved March 16, 1897, being section 34 of chapter 89 of the Session Laws of 1897, and
acts amendatory thereof and supplemental thereto.

By virtue of compliance with the provisions of said acts and the payment to the
State of Washington of the sum of One hundred and no/100 (\$100.00) Dollars, the receipt
of which is hereby certified to, the said E. W. Picco is hereby granted the right to
occupy for purposes of right of way for hauling or removing timber or ties, the lands
situate in the County of Skamania, and said State of Washington, more particularly desc-
ribed as follows:

Those portions of the N $\frac{1}{2}$ of NW $\frac{1}{4}$, SE $\frac{1}{4}$ of NW $\frac{1}{4}$ and W $\frac{1}{2}$ of NE $\frac{1}{4}$ of section 8, township
7 north, range 55 east, W.M., included within the limits of a strip of land 50
feet in width, having 25 feet of such width on each side of the following described
center line:

Beginning at a point on the south line of said section 8, which is east 1445.0
feet from the southeast corner thereof, thence running N 0° 22' W 145.0 feet; thence
N 28° 15' W 183.7 feet; thence N 42° 15' W 458.4 feet; thence N 85° 11' W 307.0 feet;
