EASEMENT DEED

THE UNITED STATES OF AMERICA, Department of the Interior, acting by and through the Bonneville Power Administrator, hereinafter called the grantor, has this day granted and conveyed, and by these presents does hereby grant and convey unto Walter J. Maguire and Mazie L. Maguire, husband and wife, hereinafter called the grantees, their heirs and assigns, a perpetual easement over and upon the following described land, to-wit:

A parcel of land being all that portion of the  $N\frac{1}{2}$  of the  $NE\frac{1}{4}$  of Section 29, T. 2 N., R. 5 E. W.M., Skamania County, Washington, which lies within a strip of land 300.0 feet in width, of which 212.50 feet lie on the northerly side of and 87.50 feet lie on the southerly side of the Bonneville-Vancouver transmission line survey; said survey line being located as follows:
