ORDER FOR PROBATE OF WILL

The duly verified petition of Jack F. Ridenour for the probate of the Will of Ada S. Ridenour, deceased, for the issuance to him of Letters Testamentary, as Executor of the said estate, coming on regularly to be heard at this time, and it satisfactorily appearing to the court and the court finds:

That Ada S. Ridenour died on the 3rd day of January, 1937, in the City of Newberg, Yamhill County, Oregon; that said deceased, at the time of her death, was a resident and an inhabitant of Yamhill County, Oregon, and left an estate in Yamhill County, Oregon, consisting of real property of the probable value of \$1000.00., and of the probable annual rental value of \$150.00.

That said deceased left a Last Will and Testament bearing date the 28th day of November, 1922, which Will the said Petitioner believes to be the Last Will and Testament of said deceased, and which Last Will and Testament is herewith presented to the Court and propounded for probate as and for the Last Will and Testament of the said Ada S. Ridenour.

That at the time the said Will was executed, to wit: November 28th, 1922, said Ada S. Ridenour was over the age of 21 years, to wit: of the age of 50 years, or thereabouts; that she was then of sound and disposing mind and not acting under restraint, undue influence or fraudulent misrepresentation; that she was then in every respect competent by last will and testament to dispose of all her estate.

Smith, both of Newberg, Oregon, as attesting witnesses; that at the time of the execution of said Will, the said C. R. Chapin and Rebecca W. H. Smith were competent to act as witnesses thereto; that the said C. R. Chapin and Rebecca W. H. Smith are still competent to act as witnesses to the execution of a Will, but that the said C. R. Chapin has since moved away from Newberg, Oregon; that the Affidavit of the said testator has been presented to the Court; that said Will was in all respects, duly and legally executed.
