ORDER APPROVING FINAL ACCOUNT AND DISCHARGING
EXECUTOR

This cause coming on regularly at this time for hearing on the Final Account of Jack F. Ridenour, Executor of the Last Will and Testament and Estate of Ada S. Ridenour, deceased, and it satisfactorily appearing to the Court and the Court finds:

That as appears from the affidavit of publication filed herein, notice of said hearing on said Final Account was duly given by publication thereof in the Newberg Graphic, a newspaper of general circulation printed and published in Yamhill County, Oregon, for four consecutive and successive weeks, in the following issues, to-wit: September 16, 23, 30 and October 7 and 14, 1937; that no objections whatsoever to said Final Account have been made or filed herein; that in all respects the above estate has been fully administered according to law; that all taxes, claims, debts, expenses and charges of any and every nature have been paid in full by said Executor from his own personal funds, and that said Executor makes no claim against said estate on account of said payments or on account of his services herein as Executor of said estate; that more than six months have elapsed since the date of the first publication of Notice to Creditors and that said estate is now ready to be closed and forever settled.

That the real property described in the Inventory and Appraisement herein, which realty is situated in Newberg, Yamhill County, Oregon, was devised and bequeathed to Jack F. Ridenour, widower of said deceased, in and by the third paragraph of the Last Will and Testament of said deceased, and that the fee simple title to said property should now pass to said devisee free from the control of said Executor.
