WARRANTY DEED

D. Bickerstaff and O'Dessa M. Bickerstaff, husband and wife, the following described real estate, situate in the county of Skamania state of Washington:

Commencing at the quarter post on the section line which runs North and South between sections thirty-three and thirty-four, township two North, Range Six, east of the Willamette Meridian, thence west 880 feet; thence north 19° 47' east 595 feet; thence east 678 feet to said section line between sections thirty-three and thirty-four, township two North, range six, east of the Willamette Meridian, thence south to the place of beginning, containing 10 acres, more or less, said tract lying in the southeast quarter of the northeast quarter of section thirty-three, township two north, range six, east of the Willamette Meridian.

Also all water rights, easements and pipe line and appurtenances thereunto belonging including especially the interest of the grantors in the easements, privileges and rights described in conveyance from E.
