Morris and Georgiann Morris, husband and wife, the following described real estate, situate in the county of Skamania, state of Washington:

Beginning at a point on the Southerly line of the Evergreen Highway which is south 1257 feet and west 38.93 feet from the common corner of Sections 15, 16, 21, and 22, in Township 2 North of Range 7 East of the Willamette Meridian, and running thence North 81 deg. 00' West, along said highway, 850 feet; thence North 79 deg. 51' West, along said highway, 300 feet to a point which is the true point of beginning of the tract herein described; and running thence North 79 deg. 51' West, along said highway, 50 feet; thence South 10 deg. 09' West 100 feet; thence South 79 deg. 51' East 50 feet; and thence North 10 deg. 09' East 100 feet to the place of beginning, said tract being designated as Lot 15, in Block 4, of the unrecorded plat of the Town of North Bonneville, Skamania County, Washington.

Beginning at the Southwest corner of the N.O. Callahan tract a point on the East line of Chesser road 1234.16 feet South of the center line of Section 36, T. 3 N.
