QUIT CLAIM DEED

Beginning at a point on the North line of State Highway No. 8 1515.08 feet West and 943.7 feet South of the Northeast corner of Section 21, Twp. 2 N. R. 7 E.W.M. running thence North 0° 46' West a distance of 100 feet thence North 79° 51' West a distance of 26 feet to the initial point; thence South 10° 09' West to the North line of State Highway No. 8 thence North 79° 51' West along the Northerly line of State Highway No. 8 to a point which is 1574 feet West of the section line between sections 21 and 22 said township and range; thence continuing along the north line of said State Highway No. 8 a distance of 33 feet thence North 100 feet, thence North 74° 51' West 17 feet thence North 100 feet, thence South 74° 51' East 50 feet, thence South 100 feet thence South 79° 51' East to the initial point EXCEPTING therefrom that parcel conveyed to H.
