Commencing at the W $\frac{1}{4}$ corner of said S. 20; thence, N. 18° 39' 30" E., 613.55 feet to the point of beginning; thence, N. 68° 39' 46" W., 250 feet to a point in the centerline of State Highway No. 68; thence, N. 21° 20' 14" E., 175 feet along said centerline to a point; thence, S. 68° 39' 46" E., 250 feet to a point; thence, S. 21° 20' 14" W., 175 feet to the point of beginning, excepting therefrom a strip of land on the east side of said centerline used as right of way for said State Highway No. 68. The herein-described tract of land to contain 0.20 acres of land, more or less.
