BAKER COUNTY

Agreement dated October 6, 1955, from Oregon State Highway Commission, granting permission to cross Old Oregon Trail at a point in S. 33, T. 12 S., R. 44 E., Baker County, Oregon. (Line 101-11, R/W 7-01-259)

MULTNOMAH COUNTY

Agreement dated April 17, 1956, from Oregon State Highway Commission, granting permission to cross Columbia River Highway at a point in S. 28, T. 2 N., R. 1 W., Multnomah County, Oregon. (Line 506-22, R/W 7-26-023)

Agreement dated May 23, 1956, from Spokane, Portland and Seattle Railway Company, granting permission to cross said Railway Company's right of way and tracks at a point in S. 28, T. 2 N., R. 1 W., Multnomah County, Oregon. (Line 506-22, R/W 7-26-022)

Agreement dated April 13, 1956, from Sauvie Island Drainage District, granting permission to cross certain dykes, levies, drainage ways, and other drainage and flood control structures under the jurisdiction of said drainage district in Multnomah County, Oregon.

Agreement dated November 28, 1955, from Department of the Army, Corps of Engineers, Portland District, Portland, Oregon, granting permission to lay two parallel submerged pipelines across the Columbia River in Multnomah County, Oregon. (Line 506-22, R/W 8-06-111)
