## STATE OF UTAH

## GRAND COUNTY

Decision dated May 24, 1956, from United States Department of the Interior, Bureau of Land Management, Land Office, Salt Lake City, Utah, granting permission to cross public lands along the route of the pipeline in S. 17, 18, 20, and 21, T. 17 S., R. 26 E., Grand County, Utah. (Line 301-49, R/W 4-10-111)

## SAN JUAN COUNTY

Compressor Station Site No. 2: Decision dated June 8, 1956, from United States Department of the Interior, Bureau of Land Management, Land Office, Salt Lake City, Utah, approving right of way for compressor station in San Juan County, Utah, being a tract of land out of S. 31, T. 28 S., R. 23 E., of the Salt Lake Base and Meridian, San Juan County, Utah, and further described as follows:

Beginning at a State Road Right of Way Marker at the intersection of the West line of U. S. Highway No. 160 and the North line of S. 31, T. 28 S., R. 23 E., Salt Lake Base and Meridian, San Juan County, Utah; thence, along the West Right of Way line of U. S. Highway No. 160 as follows:

- S. 14° 54' E. 290.4 feet to a Right of Way marker;
- S. 19° 01' E. 517.4 feet to a Right of Way marker; and
- S. 23° 57' E. 520.5 feet to a Right of Way marker;

thence, S. 68° 31' W., 1100.0 feet to a stake for corner; thence, N. 21° 29' W., 1771.4 feet to a stake for corner in the North line of S. 31, T. 28 S., R. 23 E., Salt Lake Base and Meridian, San Juan County, Utah, 895.9 feet west of the N. E. corner of the N. W.  $\frac{1}{4}$  of said S. 31, an iron pipe with a 2" brass cap, marked U. S. General Land Office Survey, 1915  $\frac{1}{4}$  Cor. Sections 30 and 31, T. 28 S., R. 23 E., thence along the North line of said S. 31, East 1217.4 feet to the point of beginning and containing 39.11 acres of land.

## UINTAH COUNTY

Vernal Metering Station Site No. 3: Decision dated May 24, 1956, from United States Department of the Interior, Bureau of Land Management, Land Office, Salt Lake City, Utah, approving right of way for metering station in Uintah County, Utah, being a tract of land out of the property of the United States of America, in a portion of the S  $\frac{1}{2}$  of the SE  $\frac{1}{4}$ , of S. 6, T. 4 S., R. 23 E., Salt Lake Meridian, Uintah County, Utah, and being more particularly described as follows:

Beginning at the SE corner of said S. 6; thence, in a westerly direction following the south boundary of said S. 6, 1374 feet to a point; thence, N. 0° 40' E., 790 feet to a point; thence, N. 11° 45' E., 74 feet to a point; thence, S. 86° 32' W., 1.8 feet to the true point of beginning said point being the NE corner of the herein-described tract, being also a point in the south right of way line of a county road (dirt); thence, S. 86° 32' W., 175 feet along the said right of way line to a point; thence, S. 3° 28' E., 50 feet to a point; thence 86° 32' E. 175 feet to a point; thence N. 3° 28' W., 50 feet to the true point of beginning. The herein-described tract of land to contain 0.20 acres of land, more or less.
