Big Piney Check Meter Station Site: Interim letter dated June 15, 1956, from United States Department of the Interior, Bureau of Land Management, Land Office, Cheyenne, Wyoming, granting permission to proceed with construction of check meter station on the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$, S. 36, T. 23 N., R. 114 W., 6th Principal Meridian, Lincoln County, Wyoming.

Compressor Station Site No. 7: Decision dated July 10, 1956, from United States Department of the Interior, Bureau of Land Management, Land Office, Cheyenne, Wyoming, approving right of way for compressor station in Lincoln County, Wyoming, being a tract of land out of Sections 2 and 3, T. 21 N., R. 118 W., 6th Principal Meridian, Lincoln County, Wyoming, and further described as follows:

Beginning at a stake set for the SW corner of said tract in the North Right of Way line of U. S. Highway No. 30-N, from which the common corner between Sections 2, 3, 10 and 11, T. 21 N., R. 118 W., 6th Principal Meridian, Lincoln County, Wyoming, bears S. 69° 08' E., 851.08 feet; thence, along the North Right of Way line of U. S. Highway No. 30-N., N. 83° 45' E., at 800.00 ft. cross the East line of S. 3 and the West line of S. 2, a total distance of 2,640.0 feet to a stake for corner; thence, N. 06° 15' W., 1,320.0 feet to a stake for corner; thence S. 83° 45' W., at 1,695.43 feet cross the West line of S. 2 and the East line of S. 3, a total distance of 2,640.0 feet to a stake for corner; thence, S. 06° 15' E., 1,320.0 feet to the point of beginning and containing 80.000 acres of land.

SWEETWATER COUNTY

Compressor Station Site No. 6: Decision dated January 27, 1956, from United States Department of the Interior, Bureau of Land Management, Land Office, Cheyenne, Wyoming, approving right of way for compressor station in Sweetwater County, Wyoming, being a tract of land out of S. 10, T. 15 N., R. 109 W., 6th Principal Meridian, Sweetwater County, Wyoming, and further described as follows:

Beginning at a stake set for the SE corner of the herein-described tract, in the West Right of Way line of a County Road from Green River, Wyoming, to McKinnon, Wyoming, from which the NE corner of S. 10, T. 15 N., R. 109 W., 6th Principal Meridian, Sweetwater County, Wyoming bears N. 36° 42' W., 1926.1 feet and East 1800.9 feet; thence, N. 36° 42' W. 1320.0 feet to a stake for corner; thence S. 53° 18' W. 2640.0 feet to a stake for corner; thence, S. 36° 42' E. 1320.0 feet to a stake for corner in the West Right of Way line of a County Road; thence, along the West Right of Way line of said County Road, N. 53° 18' E. 2640.0 feet to the point of beginning and containing 80.0 acres of land.
