Also, all the right, title and interest of the first party in and to a certain spring and stream of water mentioned and described in that certain notice of appropriation of water recorded on May 28, 1904, in Book E of Misc. records, at page 25 thereof, in and for Skamania County, Washington, and furthermore particularly described and incorporated in that certain supplemental notice of appropriation of water recorded December 19, 1911, at page 182 in Book E of Misc. Records in and for Skamania County, Washington, as acquired by virtue of the priority of said notice and by the subsequent use and appropriation of said water to beneficial use and otherwise;

Also, all the right, title and interest of first part in and to the water from the stream known as "Big Spring" mentioned and described in that certain notice of appropriation of water recorded June 1, 1917, in Book F on page 410, Misc. records of Skamania County, Washington.

Also, the following described property, situate in the County of Klickitat, State of Washington, to-wit:

The east half of the southwest quarter of the southwest quarter of the southwest quarter of Section 11, in Township 3 North, Range 10, E.W.M., containing 20 acres, more or less; also including all water rights, pipe lines and right of way thereunto belonging, or in anywise pertaining or used in connection with said land, including interest in spring and water therefrom located on hillside about one quarter mile northeast of residence of Wade Dean and pipe line and right of way used to convey water from said spring, all in Klickitat County, Washington;

Also, an undivided three-tenths interest in and to the water in that certain spring located as follows: Beginning at a point 1370 feet north and 789 and 8/10 feet east of the southwest corner of the southeast quarter of Section 11, Township 3 North, Range 10, E.W.M.; thence north 300 feet; thence east 290 and 4/10 feet; thence south 300 feet; thence west 290 and 4/10 feet to the place of beginning; also a right of way over and across the land owned or formerly owned by Maggie A. Riner, R. D. Cameron and Margaret Cameron for the transmission of said water from the said spring to the land now owned by the First Party herein; also the privileges of going in and upon said right of way for the purpose of laying and keeping in repair all necessary pipe for transmitting said water;

Also, the northwest quarter of the northwest quarter of Section 14, Township 3 North, Range 10, E.W.M., together with that part of the southwest quarter of the northwest quarter of said Section 14, lying east and north of the White Salmon River, excepting a strip of land forty feet in width, being twenty feet in width on each side of the following line:

Beginning at a point on the Section line between Sections 11 and 14, North 88° 2' east 24.9 feet from the section corner common to Sections 10, 11, 14 and 15, Township 3 North, Range 10, E.W.M., and running thence south 27° 29' east 92.1 feet; thence south 5° 31' east 116.9 feet; thence south 36° 47' west 122.95 feet to a point on the section line between Sections 14 and 15, south no degrees 58' east 296.19 feet from the said corner common to Sections 10, 11, 14, and 15, Township 3 North, Range 10, E.W.M., and containing .305 acres, more or less;

Also, excepting all that part of the northwest quarter of the northwest quarter of Section 14, Township 3 North, Range 10, E.W.M., in the counties of Klickitat and Skamania in the State of Washington, which lies westerly of a line drawn 10 feet easterly from the east bank of the White Salmon River, measured from the high water mark, also that part of the southwest quarter of the northwest quarter of said section which lies on the easterly side of the White Salmon River west of a line drawn ten feet east from the easterly bank of the White Salmon River, measured from the high water mark;

Also, a part of the northeast quarter of the northwest quarter of Section 14, Township 3 North, Range 10, E.W.M., described as follows: beginning at the northwest corner of said northeast quarter of the northwest quarter of Section 14, running thence east along the north line of said tract, 342 feet; thence south 9° 30' east 344 feet to a point in the center of a ravine; thence south 22° 30' west along the center of said ravine 123 feet; thence south 281 feet; thence south 28° 30' west 158 feet; thence south 8° 30' west 453 feet; thence west along the south line of said northeast quarter of the northwest quarter 207 feet to the west line of said northeast quarter of the northwest quarter; thence north along said west line 1320 feet to the place of beginning, containing 9.48 acres, more or less.

TOGETHER WITH ALL personal property, farm machinery and equipment now situate in, on or about said premises.

This deed is intended to convey any and all interest held by the grantors, if any.
