REAL ESTATE CONTRACT

THIS CONTRACT, made this 28th day of October, 1947 between Abbie C. Craft, a widow, hereinafter called the "seller" and Ray Earle and Lillie Earle, his wife, hereinafter called the "purchaser",

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the seller the following described real estate with the appurtenances, situate in Skamania County, Washington:

- 1. Beg. at the intersection of the E. line of Tract 2 of Columbia Home Tracts (as shown at page 76, official plat book in County Auditor's Office) with the N. line of State Road No. 8; thence W. on said N. line 100 feet; thence N. and parallel to the E. line of said Lot 2 a distance of 477 feet.; thence E. 100 ft. to said E. line; thence S. on said line 477 ft. to place of beginning, and being in Lots 11 and 12, of Sec. 36, Twp. 3 N. R. $7\frac{1}{2}$ E. W. M.
- 2. Commencing at the SW cor. of Lot 3 Columbia Home Tracts, according to the official plat thereof on file and of record in the office of the Auditor of Skamania Co., Wash.; thence N. 377 ft. following the W. boundary of said Lot 3, thence E. 250 ft. to the E. boundary of said Lot 3, thence following the E. line thereof south 319 ft. more or less to the SE cor. thereof, thence in a southwesterly direction about 255 feet following the south boundary of said Lot 3 to the place of beginning, containing two acres, more or less, all in Section 36, Twp. 3 N. R. 7½ E. W. M.

Also all roads and easements appurtenant thereto.

On the following terms and conditions: The purchase price is \$1500.00,(\$1500.00) dollars, of which \$300.00 (\$300.00) dollars is to be paid on or before December 1st, 1947, and the purchaser agrees to pay the balance of said purchase price to-wit the sum of \$1200.00 as follows: In monthly installments of not less than \$30.00 each for the months of January and February, 1948, payable on or before the 1st of January, 1948, and the 1st day of February, 1948, and thereafter in monthly installments of not less then \$50.00 each payable on or before the 1st day of each Month, commencing March 1st, 1948, Interest on unpaid balances at the rate of 6% per annum payable monthly.

The whole amount of unpaid balance and interest or any installment thereof may be paid in advance of the due date.

The purchaser agrees: (1) to pay before delinquency all payments of whatsoever nature, required to be made upon or by virtue of said mortgage, if any; also all taxes and
