EASEMENT FOR HAUL ROAD

IN THE MATTER OF Primary State Highway No. 8, Prindle to Skamania, Pit and Stockpile Sites

KNOW ALL MEN BY THESE PRESENTS, that Paul Kraetch and Rose Kraetch, husband and wife, of Astoria, Oregon; Herman Kraetch and Mathilda Kraetch, husband and wife, and Jane M. Carey and P. J. Carey, wife and husband, all of Portland, Oregon

for and in consideration of the sum of ONE dollar in hand paid, the receipt whereof is fully acknowledged, do hereby convey and warrant unto the STATE OF WASHINGTON, a perpetual easement and right of way for a haul road of sufficient width to conveniently transport highway materials and equipment for state highway purposes.

Said haul road being situated in Skamania County in the State of Washington, the center line of which is described as follows:

Commencing at the Northeast corner of the E. C. Hardy Donation Land Claim No. 41 on the Section line between Sections 19 and 30, Township 2 North, Range 7 East, W.M., approximately 281.8 feet Westerly from the Section corner common to Sections 19, 20, 29 and 30 in said Township and Range; running thence South 54°32' East a distance of 1040.5 feet to the initial point of the haul road being herein described;

thence North 33°58'30" East 326.9 feet; thence North 49°32'30" East 257.5 feet; thence North 23°47'30" East 1649.4 feet; thence North 58°38'30" East 314.5
