Harry W. Cameron et ux to Town of Stevenson

The grantors Harry W. Cameron and Iva Helen Cameron, husband and wife, of the City of Stevenson, County of Skamania, State of Washington, for and in consideration of One Hundred and no/100 dollars (\$100.00), in hand paid, convey and warrant to the Town of Stevenson, the following described real estate, situate in the County of Skamania, State of Washington, to-wit:

Beginning at the Northwest corner of Lot 2 of E. C. Hove's Orchard Tracts in Section 36, Township 3 North, Range 7 East Willamette Meridian, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington; thence in a Northwesterly direction on the same course as the Westerly line of said Lot 2 a distance of 75 feet thence East 150 feet, thence southeasterly on a course parallel to the westerly line of said Lot 2 extending Northerly a distance of 75 feet to the North line of said Lot 2 thence west 150 feet to the point of beginning.

As a part consideration for this instrument it is understood and agreed that the Town of Stevenson will when available provide used pipe taken from its water system for the purpose of conveying to the artificial lake or pond upon the premises of the Grantor surplus water from the reservoir constructed by the Grantee upon lot 2 and/or the premises hereby conveyed and will at its expense lay the said pipe lines from said reservoir to the above mentioned lake and thereafter maintain the same.
