#39092 Town of Stevenson to Carson Lumber Co.

KNOW ALL MEN BY THESE PRESENTS that the Town of Stevenson, a municipal corporation of the State of Washington, party of the first part, in consideration of the sum of One Dollar and of the benefits to be derived as provided herein does hereby give and grant unto Carson Lumber Company, a Washington Corporation, party of the second part and easement for the term of five years from the date hereof for a logging road over and across the following described real property in Skamania County, State of Washington, to-wit:

The South half of the Northeast quarter of Section 34, and the Northwest quarter of the Southwest quarter of Section 35, in Twp. 3 N. R. 7 E.W.M. and the East 100 ft. of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Sec. 34, Twp. 3 N. R. 7 E.W.M.

To have and to Hold unto the party of the second part, his heirs and assigns for the term aforesaid. This grant is given upon the following conditions and limitations:

1. That the said logging road shall be so constructed as not to interfere with the water system belonging to the party of the first part or to injure the water shed for said water system.
2. That where the said logging road shall cross the pipe line belonging to the party of the first part, a substantial bridge shall be built thereover in such manner as to fully protect the town's pipe line from damage by reason of vibration or otherwise; said
