RESOLUTION OF SHAREHOLDERS OF DEFIANCE LUMBER COMPANY

At a special meeting of the shareholders of Defiance Lumber Company, held at the office of the company at 4601 Ruston Way, in the City of Tacoma, Washington, on Friday, the 15th day of April, 1949, at 10:00 o'clock in the forenoon, the following resolution was unanimously adopted by all of the shareholders, being the holders of more than two/thirds of the voting power of the shareholders at a shareholders' meeting of said corporation duly called for the purpose.

BE IT FURTHER RESOLVED that Defiance Lumber Company, a corporation, be dissolved and wound up out of court, and that Lee L. Doud and Donald H. Doud be and they are hereby appointed and designated as trustees to conduct the winding up of this corporation and to take any and all steps necessary to completely wind up the affairs of this corporation and dissolve this corporation as provided by law.

BE IT FURTHER RESOLVED that Lee L. Doud, Donald H. Doud, Neva D. Martin and Gladys D. Martin, being all of the shareholders of this corporation and being the shareholders holding the majority of the voting power of all shareholders of this corporation cause to be made duplicate copies of this Resolution and shall sign and acknowledge the same, and cause one copy of said copies to be filed in the office of the Secretary of State and the other copy to be filed in the office of the Auditor of Pierce County, being the county in which this corporation has its registered office.
