EXECUTRIX' DEED ON CONTRACT

WHEREAS, ROSA MORGAN, unmarried and now deceased, entered into a written contract on the 30th day of March, 1943, agreeing to convey to CARL BENSON MYERS and EVA MYERS, husband and wife, certain real property hereinafter described, which contract was by CARL BENSEN MYERS and EVA MYERS, husband and wife, on March 6, 1945, assigned to GEORGE PATTON and LUELLA PATTON, husband and wife; and
