## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That I, CORINNE W. BARBER, a widow, in consideration of TEN (\$10.00) Dollars to me paid by LONGVIEW FIBRE CO., a Delaware Corporation, do hereby grant, bargain, sell and convey unto said Longview Fibre Co., its successors and assigns, all the following real property, with the tenements, hereditaments and appurtenances situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

The NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  and the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  and Lots 5, 6, 7 and 8, in Sec. 30 Twp. 7 North, Range 5 E.W.M., Skamania County, Washington, excepting therefrom the following:

A tract of land beginning at a point on the north side of County road. Said point being 1158' S of the NW corner of Lot 3, Sec. 30, Twp. 7 North, Range 5, E.W.M. running thence S 162' along the west side of Lot 3 to the SW corner of Lot 3 thence E 167' between Lots 3 and 8 to the N. bank of the Lewis River; thence S 35 deg. 50' W. 480' along the N. Bank of Lewis River; thence 26 deg. 00' W 208' along the N. bank of Lewis river; thence N 63' to a point on the N. side of the County road; thence N 63 deg. 40' E. 288' to the place of beginning. Containing 2.788 acres, more or less. Subject to road right of ways and water right of ways, etc.
