EASEMENT FOR HIGHWAY SLOPES

IN THE MATTER OF Primary State Highway No. 8, Stevenson as East City Limits

KNOW ALL MEN BY THESE PRESENTS, that C. N. Miles and Ruth G. Miles, husband and wife, of the County of Skamania State of Washington, owners of record and the Bank of Stevenson, of the County of Skamania, State of Washington, owner of that certain mortgage recorded May 28, 1947, at page 9, Book "X" of mortgages, records of Skamania County, State of Washington, for and in consideration of the sum of One and no/100 dollars in hand paid, the receipt whereof is hereby acknowledged to hereby grant and warrant unto the STATE OF WASHINGTON, the perpetual right, permit, license and easement to use and occupy the hereinafter described lands for the purpose of constructing and maintaining highway slopes in excavation and/or embankment, said lands being situated in Skamania County, State of Washington and described as follows, to-wit:

A strip of land 8 feet in width when measured Northwesterly and Southeasterly, lying adjacent, parallel and contiguous to the Southerly right of way line of said highway and more particularly described as follows:
