KNOW ALL MEN BY THESE PRESENTS, that Frank Hunsaker and Mary F. Hunsaker, husband and wife of the County of Klickitat, State of Washington for and in consideration of the sum of One & no/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged do hereby grant and warrant unto the STATE OF WASHINGTON, the perpetual right, permit, license and easement to use and occupy the hereinafter described lands for the purpose of constructing and maintaining highway slopes in excavation and/or embankment, said lands being situated in Skamania County, State of Washington, and described as follows, to-wit:

A strip of land 7 feet in width when measured Northwesterly and Southeasterly, lying adjacent, parallel and contiguous to the Northerly right of way line of said highway and more particularly described as follows:

All that portion of Lots 14 and 15, Block 8, Riverview Addition to the Town of Stevenson, lying Southeasterly of a line drawn parallel with and 37 feet distant Northwesterly, when measured at right angles, from the center line survey of said highway and extending from Highway Engineer's Station 47+80 Northeasterly to the Easterly line of said Lot 15, EXCEPTING therefrom all lands that may have heretofore been conveyed for public roads and/or highways.

The lands herein conveyed contain 490 square feet, more or less,

The specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia, Washington, and bearing date of Approval July 16, 1946, as revised August 20, 1948, and as revised April 1, 1949.
