## STATUTORY WARRANTY DEED

W.M., thence S 65°17'W 250 feet, thence S 75°15'W 300 feet, thence S 61°17'W 125 feet, thence S 35°42'W 150 feet, thence S 56°42'W 150 feet, thence S 65°08'W 149 feet, to intersection of the north line of the Baughman D L C with the west line of the SE $\frac{1}{4}$  of the NE $\frac{1}{4}$  sec 2 tp 2 N R 7 E.
