BORROW PERMIT

IN THE MATTER OF Primary State Highway No. 8, Cape Horn to Skamania

KNOW ALL MEN BY THESE PRESENTS, that Robert C. Prindle and Louise A. Prindle, husband and wife, of Washougal, Washington for and in consideration of the sum of Two Thousand Four Hundred \$2400.00 Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the exclusive right, permit, license and lease to use and occupy the hereinafter described lands at any and all times from date hereof until June 1, 1954 19__, for the purpose of excavating and removing highway materials in any quantity, consisting of rock, gravel, sand and/or earth from any portion of said lands, storing and stockpiling crushed rock or other highway materials thereon, and operating all necessary machinery and equipment thereon, said lands being situated in Skamania County, State of Washington, and described as follows, to-wit:

A tract of land containing 5.04 acres, more or less, situated in Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 2, and Lot 4, Section 11, all in Township 1 North, Range 5 East W.M., and more fully described as follows:

Beginning at the section corner, common to Sections 1, 2, 11 and 12, Township 1 North, Range 5 East W.M., thence North 71° 51' West 249.7 feet to the initial point of tract; thence from the said initial point North 24° 40 $\frac{1}{2}$ ' West 392 feet to the Southerly line of the Bonneville, Camas, Vancouver Power -line easement; thence Southwest along the South line of the said Power-line easement a distance of 71 feet to an angle point; thence Southwesterly along the South line of said Power-line easement a distance of 370 feet; thence South 25° 10' East 519.3 feet; thence North 78° 39' East 427.8 feet to a point which is South 24° 40 $\frac{1}{2}$ ' East of the initial point; thence North 24° 40 $\frac{1}{2}$ ' West 100 feet to the initial point.
