LEASE AND PERMIT TO STOCK PILE ROAD MATERIALS

IN THE MATTER OF Primary State Highway No. 8, Cape Horn to Skamania

KNOW ALL MEN BY THESE PRESENTS, THAT Robert C. Prindle And Louise A. Prindle, husband and wife, of Washougal, Washington for and in consideration of the sum of Three Hundred Fifty \$350.00 Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the right, permit and lease to use and occupy exclusively the hereinafter described lands for the purpose of depositing, storing and stockpiling crushed stone and other highway materials thereon at any and all times from date hereof until June 1, 1954 19__, said lands being situated in Skamania County, State of Washington, and described as follows, to-wit: a tract of land containing 2.42 acres, more or less, lying and being Northwesterly of Primary State Highway No. 8, Cape Horn to Skamania, situated in the Southwest Quarter of the Southeast Quarter of Section 1, Township 1, Range 5 East, W.M., and more fully described as follows: Commencing at the Southwest corner of Section 1, Township 1 North, Range 5 East, W.M., thence East 2000 feet, thence South 23 feet to the Northerly line of the Evergreen Highway, thence North 57° 20' East along the Northerly line of the Evergreen Highway a distance of 1382.2 feet to the initial point. The said initial point being intersection of the Northerly line of the Evergreen Highway and with the Westerly line of the County Road, thence from said initial point North 30° 15' East 120 feet, thence North 35° 06' West 225 feet, thence North 73° 25' West 470 feet, thence South 180 feet to the Northerly line of the Evergreen Highway, thence South 57° 20' West along the Northerly line of said Evergreen Highway 453 feet to the initial point.
