LEASE AND PERMIT TO STOCKPILE ROAD MATERIALS

IN THE MATTER OF Primary State Highway No. 8, Cape Horn to Skamania,

KNOW ALL MEN BY THESE PRESENTS, that Paul J. Vial and Florence H. Vial, husband and wife, of Washougal, Washington for and in consideration of the sum of Two Hundred Twenty Five (225.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the right, permit and lease to use and occupy exclusively the hereinafter described lands for the purpose of depositing, storing and stockpiling crushed stone and other highway materials thereon at any/times from date hereof until June 1, 1952 19__, said lands being situated in Skamania County, State of Washington, and described as follows, to-wit:

A strip of land containing 1.91 acres, more or less, lying and being Southerly of a line drawn parallel with and 300 feet distant Northerly, when measured at right angles and/or radially from the center line survey of said highway; extending from Highway Engineers Station 655+00, Northeasterly to Highway Engineers Station 658+50; EXCEPT all that portion of the said strip of land that may have been heretofore conveyed for highway purposes.
The hereinbefore described strip of land is situated in Section 6, Township 1 North, Range 6 East W.M.

The specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways and bearing date of approval April 22, 1949 Revised April 29, 1949.
