M. HEGEWALD and HELEN HEGEWALD, husband and wife, the following described real estate, situated in the County of Skamania, State of Washington:

Commencing at station 47+86 of survey of Spokane, Portland & Seattle Railway Company's right of way in Section One (1), Township Two (2) North, Range Seven (7) East of Willamette Meridian; thence on a course at right angles to the Southwest line of said railway right of way, a distance of 100 feet, to the Southeasterly line of said railway right of way to the true point of beginning; thence 400 feet Westerly along the Southeasterly line of said railway right of way; thence at right angles Southeasterly to the meander line of the Columbia River; thence following the meander line in a Northeasterly direction to the Southeasterly corner of a tract of land conveyed to R.
