WARRANTY DEED

The grantor Lloyd Bell, a single man of the city of Stevenson, county of Skamania, State of Washington, for and in consideration of One and no/100 (\$1.00) dollars, in hand paid, convey and warrant to Luther D. Morgan and Velma Cleo Morgan, husband and wife, the following described real estate, situate in the county of Skamania state of Washington:

(1) Commencing at the SE corner of Block 8, of Town of Stevenson, thence S. 55° 30' W. 266.5 feet, thence N. 25° W. 148.5 feet to the point of beginning of tract to be conveyed; thence N. 25° W. 80 feet more or less to the south line of the property commonly known as the "Gillette Property" thence west 65.5 feet to the west line of the said Henry Shepard D.L.C. thence south along the West line of the said Henry Shepard D.L.C. 90 feet; thence in a northeasterly direction to the point of beginning.

(2) Beginning at the NE corner of tract above described thence S. 25° E. 44 feet; thence in a northerly direction to intersection with the south line of the above mentioned Gillette property, at a point $14\frac{1}{2}$ feet E. of the point of beginning; thence W. $14\frac{1}{2}$ feet to point of beginning.
