SPECIAL WARRANTY DEED (Corporation)

KNOW ALL MEN BY THESE PRESENTS, That MID COLUMBIA OIL COMPANY a corporation of the State of Oregon, in consideration of Ten and no/100 Dollars, the receipt whereof/hereby acknowledged, does hereby grant, bargain, sell and convey unto Northwest 6il Co., an Oregon corporation, its successors and assigns forever, the following described real property, situate in the County of Skamania and State of Washington to-wit:

Beginning at a point on the Southerly line of the Evergreen Highway which is South 1257 feet and West 38.93 feet from the common corner of Sections 15, 16, 21 and 22 in Township 2 North of Range 7 East of the Willamette Meridian, and running thence North 81 degrees 00' West, along said highway 850 feet; thence North 79 degrees 51' West along said highway 850 feet to a point which is the true point of beginning of the tract herein described; and running thence North 79 degrees 51' West along said highway 75 feet; thence South 10 degrees 09' West 22.805 feet; thence South 71 degrees 40' East 75.771 feet, more or less, to a point that is South 10 degrees 09' West from the place of beginning; thence North 10 degrees 09' East 33.56 feet to the place of beginning, said tract being designated as all of Lot 26 and the East 25 feet of Lot 27 in Block 4 of the unrecorded plat of the Town of North Bonneville, in Skamania County, Washington;
