REAL ESTATE CONTRACT

THIS CONTRACT, made this 18th day of August, 1948, between William R. Thompson and Marion I. Thompson, husband and wife, hereinafter called the "seller" and Harry R. Cole and Cole, his wife, hereinafter called the "purchaser",

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the seller the following described real estate with the appurtenances, situate in Skamania County, Washington:
