WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That HENRY CLINE and CORA B. CLINE, husband and wife, whose name is also spelled "KLINE" in the title record of the property herein, and F. A. ROBY and IDA M. ROBY, husband and wife, in consideration of SEVEN HUNDRED FIFTY and NO/100 Dollars, to them paid by A. J. BARBEE do hereby grant, bargain, sell and convey unto said A. J. BARBEE his heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

Beginning at the Northeast corner of the Southeast quarter of Section Eighteen Township Three North Range Ten East of the Willamette Meridian and running thence West Three Hundred Twenty rods to the township line between Ranges Nine and Ten east of the Willamette Meridian. The said point being the Northwest corner of Lot Three, Section Eighteen, Township Three North Range Ten East of the Willamette Meridian; thence South on said Township line Sixty-six and two-thirds rods; thence East three hundred twenty rods to the section line between sections seventeen and eighteen in said township three North, thence North on said section line sixty-six and two-thirds rods to place of beginning, containing one hundred thirty-three and one-third acres.

To Have and To Hold, the above described and granted premises unto the said A. J. BARBEE his heirs and assigns forever

And HENRY CLINE and CORA B. CLINE, husband and wife, and F. A. ROBY and IDA M. ROBY, husband and wife, the grantors above named do covenant to and with the above named grantee, his heirs and assigns that they lawfully seized in fee simple of the above granted premises, that the above granted premises are free from all incumbrances, excepting all taxes now due and payable and hereafter becoming due and payable; and that they will and their heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever, except as above.
