DEED Bargain and Sale

Carter do hereby grant, bargain, sell and convey unto said J. R. Carter her heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

Beginning at the Northeast corner of the Southeast Quarter of Section Eighteen Township Three North Range Ten East of the Willamette Meridian and running thence West Three Hundred Twenty rods to the Township line between Range Nine and Ten East of the Willamette Meridian. The said point being the Northwest Corner of Lot Three, Section Eighteen, Township Three North Range Ten East of the Willamette Meridian; thence South on said Township line Sixty-six and two-thirds rods; thence East Three Hundred Twenty rods to the Section line between Sections Seventeen and Eighteen in said Township Three North, thence North on said Section line Sixty-six and Two-thirds rods to the place of beginning, containing One Hundred Thirty-three and One-third acres.
