Parcel No. 1: Commencing at a point 924 feet East and 991 feet North of the intersection of the West boundary of the Joseph Robbin D.L.C., with south boundary of Section 27, Tp. 3 N. R. 8 E.W.M., said point of beginning being on the easterly line of the tract of land conveyed to C. J.
