QUIT CLAIM DEED

THE GRANTORS, MERRITT BLOXOM, JR., VIRGINIA TURNER, and BETTY CROCKETT (who own the herein referred to property individually rather than as communities), for and in consideration of Ten Dollars (\$10.00) and other valuable consideration, convey and quit claim to JOHN M. BLOXOM, as trustee, all of their interest in all real property commonly known as "Joint Owners Realty Credit Properties" or "Realty Credit Properties" and which property is more particularly described as follows, to-wit:

The following described property, situate in the County of Klickitat, State of Washington, to-wit:

All of the northwest quarter of the northwest quarter of Section 11, Township 3 North, Range 10, E. W. M.,

Also, all of the northeast quarter of the northeast quarter of Section 10, Township 3 North, Range 10, E.W.M.,

Also, all of the northwest quarter of the northeast quarter of Section 10, Township 3 North, Range 10, E.W.M., except that part thereof lying west of a line commencing at a point on the north line of said Section 10, which is 212.5 feet east of the north quarter corner of said Section 10; thence south parallel with the north and south center line of said Section 10 a distance of 703 feet; thence southeasterly a distance of 703.5 feet to the south line of the northwest quarter of the northeast quarter of said Section 10, said property excepted being owned by the Northwestern Electric Company;

Also, all of the southeast quarter of the northeast quarter of Section 10, Township 3 North, Range 10, E.W.M., except a strip of land along the east side thereof described in the deed to Ethel C. McKercher and Jean McKercher filed in the office of the Auditor of Klickitat County, Washington, on the 27th day of November, 1911, and recorded in Vol. 33 of Deeds, page 346 thereof;

Also, all of the east half of the southwest quarter of the northwest quarter of Section 11, Township 3 North, Range 10, E.W.M.,

Also, all of the north half of the west half of the southwest quarter of the northwest quarter of Section 11, Township 3 North, Range 10, E.W.M., except that part thereof conveyed to Emma Lucille McKercher by deed dated May 28, 1903, which deed is now of record in the office of the Auditor of Klickitat County, Washington, in Volume P of Deeds, at page 237 thereof;

Also, all that part of the north half of the south half of the southwest quarter of the northeast quarter of Section 10, Township 3 North, Range 10, E.W.M., lying east of a line beginning at a point in the south line of said tract 803.3 feet west of the southeast corner of said tract, running thence northerly to a point 752 feet west of the northeast corner of said tract; together with all water rights, appurtenances and hereditaments thereunto belonging, or in any way appertaining;

Also, all flumes, conduits and pipe lines used in conveying or distributing water to or upon said above described premises and wheresoever situate, and also all rights of way for such flumes, conduits and pipe lines wheresoever situate, particularly a right of way across lands of the Northwestern Electric Company in the northwest quarter of the northeast quarter of said Section 10, subject, however, to all existing rights and easements over and across said land, or any part thereof;
