The grantors W. L. Jones and Frances N. Jones, husband and wife, state of Oregon, for and in consideration of One (\$1.00) dollars, in hand paid, convey and warrant to L. R. Paasch the following described real estate, situate in the county of Skamania state of Washington:

Beginning at the Northeast corner of the Elizabeth Snooks Donation Land Claim which initial point is also the Southeast corner of Lot 13, Section 25, Twp. 2 N. R. 6 E.W.M., thence North to the Northeast corner of said Lot 13 thence East along the North line of said Lot 13, a distance of 660 feet; thence South to the South line of said Lot 13, thence North 89° 56' East along the South line of said Lot 13 to a point which is 554 feet distant from the initial point; thence South 42° 43' East to a point on the north bank of the Northbank Highway (State Highway No. 8), thence following north line of State Highway in a northeasterly direction to intersection with the west line of the Hardy Donation Land Claim, thence Northerly along west line of the Hardy Donation Land Claim to the initial point.
