WARRANTY DEED.

THE GRANTORS, Frank Birkenfeld and Ruth Birkenfeld, husband and wife, for and in consideration of the sum of Ten (10.00) Dollars, in hand paid, convey and warrant to Lavera N. Standish the following described real property located in Skamania County, State of Washington:

The SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 15, and the W $\frac{1}{2}$  of the NE $\frac{1}{4}$  of Section 22, Township 3 North, Range 8, East of the Willamette Meridian.  
Also: The SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 15, and the East  $\frac{1}{2}$  of the NW $\frac{1}{4}$  and the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 22, Township 3 North, Range 8 East of the Willamette Meridian.  
Also: The SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 15, and the E $\frac{1}{2}$  of the NE $\frac{1}{4}$  of Section 22, all in Township 3 North Range 8 East of the Willamette Meridian.
