PURCHASER'S ASSIGNMENT OF REAL ESTATE CONTRACT

For value received the undersigned assignor, holder of that certain real estate con- tract entered into on the 15th day of December 1943, between Paul J. Vial and Florence H. Vial, husband and wife, as sellers and Eugene Fersen, a bachelor as purchaser, for the sale and purchase of the following real estate situated in Skamania County, Washington; to-wit:

The East half of the Southeast quarter (E $\frac{1}{2}$ of SE $\frac{1}{4}$) of Section Thirty-one (31) in Township Two (2) North, Range Six (6) East of the Willamette Meridian, in Skamania County, Washington; and also

So much of the East half of the Northeast quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$) of Section Six (6) and the West half of the Northwest quarter (W $\frac{1}{2}$ of NW $\frac{1}{4}$) of Section Five (5) as is now owned by the Sellers and which lies North of the North side line of the Evergreen Highway, and which lies North and East of a line commenc- ing on the North line of the Evergreen Highway fifty (50) feet East of the East line of a vegetable garden now owned and maintained by the Sellers, running thence North to the rim of the cliff, and thence following the rim of the cliff in a westerly and northerly direction to the North line of Section Six (6); all located in Township One (1) North, Range Six (6) East of the Willamette Merid- ian, in Skamania County, Washington;
