QUIT CLAIM DEED

THE GRANTOR, EUGENE FERSEN, an unmarried man, and who was unmarried at the time of acquisition of the following described properties, and at all times thereafter, for and in consideration of the sum of Ten and no/100 (\$10.00) Dollars, and other good and valuable considerations to him paid, hereby conveys and quitclaims to The Lightbearers, a corporation of the State of Washington, the following described real estate situated in the County of Skamania, State of Washington:

The south half of the southwest quarter (S $\frac{1}{2}$ SW $\frac{1}{4}$) of Section twenty-eight (28) in Township Two (2) North, Range Six (6) East W.M., EXCEPT the following:

Beginning at the southeast corner of the SW $\frac{1}{4}$ of said section, town. and range, and run. thence west about 29 rods to the east line of the County Road; thence northerly along the County Road to a point 70 rods north of the place of beginning; thence south to the place of beginning, containing 6 acres so excepted, containing 74 acres, more or less;

The North half of the southeast quarter; the north half of the southeast quarter of the southeast quarter; all in Section 28, Township 2 North, Range 6 East W. M. Also fifteen acres of land described as follows: Beginning at the Southeast corner of the southeast quarter of the southeast quarter of section 28, T. 2 N. R. 6 E. W. M., running thence north 660 feet; thence west 990 feet; thence south 660 feet; thence east 990 feet to the place of beginning; situated in Section 28, Township 2 North, Range 6 East W.
