The West half of the Southeast quarter; the Northeast quarter of the Southwest quarter and the Southeast quarter of the Northwest quarter of Section 29 in Township Two North, Range Six East of the W.M.

Lots 3 and 4, Southeast quarter of Southwest quarter and South half of Northeast quarter of Southwest quarter of Section Thirty-one, Township Two North of Range Six East of the Willamette Meridian.

Except roadway conveyed to Cripe and Smith by agreement dated February 8, 1911 recorded at page 204 Book 2 of Agreements and Leases, and Tract of land containing 32/100 acres, more or less, conveyed to Ira Smith and J. J. Cripe by deed dated May 9, 1911 recorded at page 235 Book "N" of Deeds, records of Skamania County, Washington.

All of the Southwest quarter (SW $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-one (31) Township Two (2) North, Range Six (6) East W.M.; containing forty (40) acres.

The West Half of the Southwest Quarter; the Southeast Quarter of the Southwest Quarter and the South Half of the Northeast Quarter of the Southwest Quarter, of Section Thirty-one (31), Township Two (2) North of Range Six (6), East of the Willamette Meridian.

The East half of the Northeast quarter of Section Thirty-one (31) and the West Half of the Northwest Quarter of Section Thirty-two in Township Two North of Range Six east of the Willamette Meridian, containing One Hundred Sixty Acres.

The north half (N $\frac{1}{2}$) of the northeast quarter (NE $\frac{1}{4}$) and the southwest quarter (SW $\frac{1}{4}$) of the northeast quarter (NE $\frac{1}{4}$) of Section thirty-two (32), Township two (2) North, Range six (6) East of the Willamette Meridian.
