Street, in San Francisco, California, or its successor in said trust, such registration being noted hereon after which no valid transfer hereof can be made except on said books, the new registration being similarly noted hereon, until after registered transfer to bearer, but after such registered transfer to bearer, this bond shall be again transferable by delivery. Such registration shall not affect the negotiability of the coupons, which shall always be payable to bearer and transferable by delivery.

As provided in the Indenture, coupon bonds at any time outstanding, when surrendered with all unmatured coupons attached, and upon payment of the charges provided in the Indenture, may be exchanged for an equal aggregate principal amount of regis-
