WARRANTY DEED

THE GRANTORS, JOHN R. MONTCHALIN and EMILY MONTCHALIN, husband and wife, for and in consideration of Ten Dollars (\$10.00) and other valuable considerations to them in hand paid by ST. HELENS PULP AND PAPER COMPANY, a corporation, receipt whereof is hereby acknowledged, convey and warrant to said St. Helens Pulp and Paper Company, a corporation its successors and assigns, an undivided one-half interest in and to the following described real estate situate in the county of Skamania, state of Washington, to-wit:

All of Section 1; the south half of the southeast quarter (S_2^1 SE $_4^1$), and the northeast quarter of the southeast quarter (NE_4^1 SE $_4^2$) in Section 11; the east half of the southeast quarter (E_2^1 SE $_4^1$), the southwest quarter of the southeast quarter (SW_4^1 SE $_4^1$), the southwest quarter of the northeast quarter (SW_4^1 NE $_4^1$), the northwest quarter of the southwest quarter (NW_4^1 SW $_4^1$), and the south half of the southwest quarter (S_2^1 SW $_4^1$) in Section 12; all of Section 13; the east half (E_2^1), the east half of the west half (E_2^1 W $_2^1$), the southwest quarter of the northwest quarter (NW_4^1 SW $_4^1$) in Section 14; the east half of the northeast quarter (E_2^1 NE $_4^1$), the north half of the southeast quarter (NV_2^1 SW $_4^2$) in Section 24; the east half of the northeast quarter (E_2^1 NE $_4^1$) in Section 25; the northwest quarter of the northwest quarter of the northeast quarter (NW_4^1 NW $_4^1$ NW $_4^1$ NI $_4^1$) in Section 35; all in Township 2 North, Range 5, East of the Willamette Meridian.
